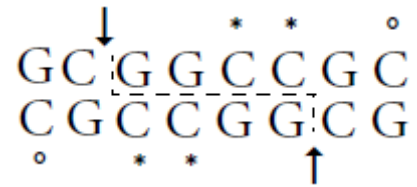

1.2. Storage and Stability

Storage Conditions (Product)

The product is shipped on dry ice.

When stored at -15 to -25°C, the product is stable through the expiration date printed on the label.

1.3. Application

Not I recognizes the sequence GC/GGCCGC and generates fragments with 5'-cohesive termini. Not I belongs to the class of "rare-cutter" enzymes. It is one of the two known enzymes recognizing an octameric sequence comprised solely of G and C residues. Not I cleaves prokaryotic genomic DNA to generate fragments between 20 and 1,000 kb depending on the GC content. Yeast genomic DNA is cleaved by Not I to generate fragments of 200 kb average length and mammalian genomic DNA to approximately 1,000 kb.

2.2. Protocols

The following steps describe a typical experiment.

- 1 Prepare the restriction digest according to the following table.

- 2 Incubate at +37°C for 1 hour.

2.3. Parameters

Activity in PCR Buffer

0%

Relative activity in PCR mix (Taq DNA Polymerase buffer) is 0%. The PCR mix contained λ target DNA, primers, 10 mM Tris-HCl (pH 8.3, +20°C), 50 mM KCl, 1.5 mM MgCl₂, 200 µM dNTPs, 2.5 U Taq DNA polymerase. The mix was subjected to 25 amplification cycles. After addition of 100 mM NaCl to the restriction digest in the PCR mix, the activity of Not I still remains very low at <5%.

Inactivation

Not I can be heat inactivated by incubation at +65°C for 15 minutes (tested up to 100 U/ μ g DNA).

Isoschizomers

The enzyme is not known to have isoschizomers.

Methylation Sensitivity

Not I is inhibited by the presence of 5-methylcytosine, as indicated (*). The presence of 5-methylcytosine in the 5'-C position is not inhibiting (°).

Unit Definition

One unit is the enzyme activity that completely cleaves 1 μ g pTRE57 DNA in one hour at +37°C in a total volume of 25 μ l SuRE/Cut Buffer H.

3. Troubleshooting

Observation	Possible cause	Recommendation
Inhibition or alteration of recognition specificity of restriction enzyme.	Compounds were used in the isolation of the DNA substrate, such as phenol, chloroform, ethanol, SDS, high levels of NaCl, and metal ions, such as Hg ²⁺ and Mn ²⁺ .	Remove compounds by ethanol precipitation followed by drying, before adding DNA to the restriction digest reaction. <hr/> Mix vial of restriction enzyme gently but completely prior to use.
